## Manufacturer's Certification Statement

Trinity Glass International, Inc. Manufacturer's Certification Statement certifies that the Signamark exterior fiberglass door systems may be eligible for federal income tax credit as defined under the "Protecting Americans from Tax Hikes Act of 2015" extending Non-business Energy Property Credit, retroactive from January 1, 2015 through December 31, 2016 (on IRS form 5695). While most door styles within the Signamark exterior fiberglass door systems may qualify for the 2015/2016 tax credit based on ENERGY STAR criteria, the following exterior fiberglass door systems do **not** qualify:

- Oak Woodgrain and Smooth Fiberglass:
  - Triple Pane Full Lite Decorative Doors (Southern and South-Central Region)
  - Dual Pane Full Lite, ¾ Lite, Half Lite Wrought Iron, Groove & Bevel Collection Doors
  - Dual Pane Full Lite Wrought Iron, Groove & Bevel Collection Sidelites –with wood jambs
  - Dual Pane Full Lite and Half Lite Wrought Iron, Groove & Bevel Collection Sidelites –with PVC jambs
  - Any Mini Blind Doors and Sidelites
  - Any door style with a Pet Door Installed
- Mahogany Woodgrain Fiberglass:
  - Dual Pane ¾ Lite Wrought Iron, Groove & Bevel Collection Doors
  - Dual Pane Full Lite Wrought Iron, Groove & Bevel Collection Sidelites –with PVC jambs
  - Any Mini Blind Doors and Sidelites
- Oak Woodgrain and Smooth Fiberglass Patio and Smooth Impact Fiberglass:
  - Triple Pane Full Lite Decorative Doors –with PVC jambs (Southern and South-Central Region)
  - Triple Pane Full Lite Impact Doors –with PVC jambs (Southern and South-Central Region)
  - Dual Pane Full Lite and Half Lite Impact Doors
  - Dual Pane Full Lite, ¾ Lite, Half Lite Wrought Iron, Groove & Bevel Collection Doors
  - Dual Pane Half Lite Wrought Iron Sidelites –with wood & PVC jambs
  - Dual Pane Half Lite Groove Sidelites –with PVC jambs
  - Dual Pane Half Lite Impact Sidelites –with PVC jambs
  - Any Mini Blind Door and Sidelites
- All Transoms (Note: Door Unit can be submitted, but not the cost of the transom)

The tax credit extension applies to products purchased and installed from January 1, 2015 to December 31, 2016. Homeowners should retain the Manufacturer's Certification Statement and purchase receipt for their records. There are new rules pertaining to a \$500 credit limit that a homeowner can claim. Always consult your tax advisor to confirm whether you qualify for the tax credit.
